

# The Fountainhead Campus Announces Expansion

*Community Health Center and Health Care for Elderly Coming to Holly Hill*

**Holly Hill, FL (November 17, 2023)** - Fountainhead Developers announced today that it is expanding its Holly Hill Campus and welcoming a new partner to the 23-acre campus - BoldAge PACE - and is also negotiating to bring Aza Health to the campus.

Jayson Meyer, the founder of The Fountainhead, made the announcement at the Volusia County Economic Development "Q Breakfast." Meyer was joined for the announcement by representatives of both organizations. Contingent upon approval by the City of Holly Hill, the expansion will include more than 36,000sf of new construction that will make a variety of health care services available to the local community.

*"The mission of my company, Synergy Billing, is to make certain that Americans have access to quality, affordable health services. Bringing Aza Health and BoldAge PACE to The Fountainhead is a natural extension of the vision that has made us successful,"* said Meyer. Meyer is also the founder and CEO of Synergy Billing, one of the anchor tenants at The Fountainhead campus that provides medical billing services to non-profit health clinics.

BoldAge PACE ([www.boldagePACE.com](http://www.boldagePACE.com)) provides personal and health support services to thousands of low-income elders across the United States. Their location at the Fountainhead Campus will serve as their Volusia County Headquarters. PACE, which stands for Programs of All-Inclusive Care for the Elderly, uniquely provides a total health and personal care solution that enables seniors to remain living independently in their homes. *"We are passionate about the health and quality of life of our participants"* said President Dan Czermak. *"The Fountainhead PACE will be one of our premier locations."*

Aza Health ([www.azahealth.org](http://www.azahealth.org)) is a non-profit Federally Qualified Health Center (FQHC) that employs 250 staff and operates eleven full-time primary care centers, three full-time dental centers, and nine full-service pharmacies across six counties in North/Central Florida. *"With this location, we would be able to expand the services we offer to thousands of underserved Volusia County residents."* said Aza Health CEO Laura Spencer. *"Co-locating with PACE would enhance the care offered to all of our patients."*

*The Fountainhead campus is the redevelopment of the former Holly Hill Middle School. It was developed by locally-born entrepreneur Jayson Meyer, who envisioned it as a corporate campus that would offer access to health care, amenities for employees, a vocational school for workforce development, and on-premises affordable workforce housing. Meyer moved Synergy Billing to the site in June of 2019. The campus is located at 1200 Synergy Way in Holly Hill, FL.*
